Attention is drawn to the Eastrington Show Health & Safety Policy which is available for inspection on www.eastringtonshow.co.uk and at the Secretary's Tent on Show Day.

 The Show Committee advises that due to the rural nature of the terrain of this event it may be at times difficult for spectators to move around freely.

- All spectators, competitors, exhibitors, vendors and their representatives enter at their own risk and are advised to wear suitable footwear, clothing and safety equipment.
- Owners, representative and riders of any animal are advised that the Showground is situated near a railway line which may result in sudden train noise.
- Parents and Guardians are advised to supervise their children at all times.
- Any person with special access needs is advised to contact a member or representative of the Show Committee for assistance.
 Contact details are also available on the website.
- Any competitor, exhibitor, vendor or their representatives bringing any animal on to the showground that is likely to come in to contact with members of the public, is responsible for following the HSE advice document 'ACD P/96/P6/Annex1 – Preventing or Controlling III Health from Animal Contact at Visitor Attractions'. In such circumstances then hand washing facilities must be provided by the aforementioned persons for use by the public.

Cancellation or Abandonment of the Event

The Show Committee (or agents) shall not be liable in respect of any loss or damage whatsoever arising from the abandonment, cancellation or

postponement of the Eastrington Show or any such eventuality. Such cancellation or abandonment would include consideration of adverse conditions caused by weather or Health & Safety considerations.

Vehicular Access and Admission

As a condition of entry or participation in the Show, all vehicles must be parked as directed by Stewards.

As a condition of entry, admission of the public is subject to a charge as defined from time to time by the Show Committee.

Disclaimer of Liability

The Show Committee and its Agents reserve the right to refuse admission to Eastrington Showground to any person, or to withdraw permission at any time to remain in the Showground and shall not be required to give any reason for such action. Save for the death or personal injury caused by the negligence of the Committee or anyone for whom they are responsible, neither the Show Committee, nor any agent, employee or representative of these bodies accepts any liability for any accident, loss, damage, injury or illness to horses, animals, owners, riders, grooms, spectators, land or any other person or property whatsoever, whether caused by their negligence, breach of contract or in any other way whatsoever.

Exhibits are at owner's risk. The Show Committee will not be responsible for loss or damage by accident or otherwise in the show ground or approach thereto.

<u>Light Horses, Ponies and Showjumping</u>

All riders must wear protective head gear which conforms to standard BS 4472 or BS6473. However, riders taking part in qualifiers must wear riding hats which conform to EN1384 or PAS015 or any hat prefixed with Standard SEI. Such head gear must be worn with the chin strap properly adjusted and fastened when mounted in the arena, practice area and collecting ring.

All owners or representative must have animal passports where required by law or regulation.

Any protests must be lodged with the Secretary on the day of the Show. Exhibits are at owner's risk. The Society will not be responsible for loss or damage by accident or otherwise in the show ground or approach thereto. The Show Committee reserves the right to cancel or amalgamate classes. Doctoring, blistering or tampering of stock strictly prohibited. All horses/ponies must be in acceptable condition.

No person shall ill-treat an animal at the show whether inside or outside the arena, or misuse whip or spurs.

No foals permitted under three weeks of age.

Exhibitor's equipment and effects are at owner's risk.

Animals of any kind should not be left unsupervised at any time. All trade and exhibitor's vehicles and trailers, or any vehicle used in transportation of animals must be parked or removed as directed by Stewards.

Cattle, Sheep, Heavy Horses and animals of any kind.

No cattle, sheep or animal from any stock in which there has been infectious disease within three months preceding the show to be admitted to competition or within the show ground.

All exhibitors must have animal passports where required by law or regulation. The age of stock in all cases to be calculated from 1st January, except where otherwise stated.

Exhibits are at owner's risk. The Show Committee will not be responsible for loss or damage by accident or otherwise in the show ground or approaches thereto. Doctoring, tampering or blistering of stock strictly prohibited. No person shall illtreat an animal at the show whether inside or outside the arena, or misuse whip or spurs.

Animals of any kind should not be left unsupervised at any time.

All vehicles must be parked or removed as directed by Stewards.

Exhibitors and Vendors

Exhibitors, vendors, contractors attending the Show employed to set up/take down stands, exhibits, marquees, provide goods or services etc. to the public must submit appropriate health and safety policies, risk assessments and method statements before the Show date.

Such exhibitors, vendors and contractors shall comply with any regulations / legislation (Statutory or otherwise) applicable to their operation.

The Society will not be responsible for loss or damage by accident or otherwise in the show ground or approach thereto.

All vehicles, including trailers, must be parked or removed as directed by Stewards.

Live animals are not permitted for sale or display (including being given away as prizes) without a current valid licence to sell pets or a licence for training and keeping animals for exhibition with the relevant Local Authority.
